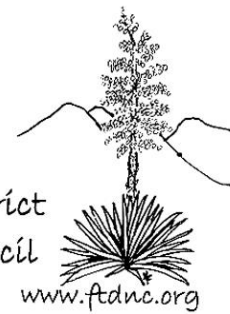

 - b) 9687 Sunland, Shadow Hills – add 97 sq. ft. to store frontage. DIR 2015-1083SPP.
 - c) 10656/10700 Tuxford, La Tuna Canyon – lot line adjustment to add another house on slightly less than 3 RAK acres. AA 2015-1359 PMEX.
 - d) 10929 Foothill Blvd., Lake View Terrace – Add 492 sq. ft. to existing sfr on 9675 RAK sq. ft. lot DIR 2015-996SPP.
 - e) 10743 Walnut, Shadow Hills – add cabana, BBQ trellis and bath – no case#.
 - f) 10231 McBroom, Shadow Hills – add 924 sq. ft. to sfr, build 7000 sq.ft. storage building and a 1200 sq.ft. greenhouse. DIR 2015-1331SPP.
