The Foothill Trails Neighborhood Council met on October 28, 2025, with quorum established. The meeting focused on public safety, transportation and infrastructure, the freeway sound wall, committee participation, and the council’s constrained budget.

- Officer Godoy reported that Lake View Terrace crime was trending toward a reduction of more than 10%, with no known RVs or tents on local streets that morning. City representatives also discussed speeding countermeasures, street-light repair delays, homeless-encampment work, and infrastructure improvements.
- Assemblywoman Celeste Rodriguez’s office said Metro had agreed to attend an upcoming board meeting to discuss the long-running sound-wall project and its study and approval process. The council also discussed strengthening inactive or understaffed committees and plans to begin streaming meetings on YouTube.
- The council reported about \$24,552 available before several months of office rent and other expenses. It approved routine financial and operating items and, because of limited funding, reduced three Neighborhood Purpose Grants to \$1,000 each for Lake View Terrace Friends of the Library, ST Forward, and Tierra del Sol; the ST Forward grant remained contingent on city approval.
