With the help of this grant we would be able to eventually reach our goal of opening a Special Spirit Farmer's Market. This special market would be an avenue for our community to interact with our farmers and in turn give our farmers a chance to practice their social and work skills in a safe and professional environment.

Our garden program incorporates not only the learning of gardening, but knowledge of science, mathematics, the arts and many other interdisciplinary topics that are required to be successful in

gardening. For example, a student will practice graphing, illustration, record keeping, and biology by depicting the growth of a bean plant from seed to bean.

Through our garden work, we grow a deepened awareness of self, the world around us, and the interconnectedness of all things, just as how our farmers will grow their crops.



4) Please describe the purpose and intent of the grant.

AHEAD With Horses purchased a 2 1/2 acre vacant lot at the end of 2017 for our Forever Home. Since then, we have been working on the Planning forms, permits, Land use Permit, etc and have had delays since we started. As a result, we are paying both our Mortgage on the property and the rent for our current place of operation. With the COVID-19 pandemic, we have been closed completely for a few months and then were able to have some of the students return. We now have only 11-13 per week instead of the former 39 per week and consequently our budget is stretched. Some donations that come in yearly have been stopped also since dinners and events were stopped. We are now trying to get as much accomplished and ready for when we can move to the property. Some projects, eg, the restroom have been funded but we are waiting for the permits.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

The Grant will help to purchase one of two 16 ft rolling gates for entrance on Foothill and for replacement fencing for some sections of the fence that are rusted or have been bent beyond repair. Included are the fence posts, cement to hold the posts and slats for the front fencing for more privacy. With these items, the property will be completely fenced in for protection of the Horses, children and equipment.
